To build a sustainable project, you must reflect in depth and define clear and achievable goals.

Is entrepreneurship for you?

→ This professional choice requires a significant investment, have you measured it correctly?

→ At first, you will likely handle all the tasks related to management, accounting, production, and business development. Is this compatible with your life project? Your health status?

Where are you in the construction of your business project?

→ Are you at the beginning phase or have you already built your project?

→ Have you launched your market research, identified your customers and settled the technical aspects of your future activity (resources, cost areas, necessary investments, etc.)?



The Services and financial aid from Agefiph

To help you carry out your project, Agefiph offers financial aid and allows you to benefit from the advice of a business creation specialist.

Support

The Pôle Emploi, Cap Emploi or Mission Locale adviser supports you in your job searching procedures.

If you want to create your own job and your business project is solid, your employment adviser can call on a service provider specializing in business creation selected by Agefiph.

Market study, financing plan, choice of business status... It supports you before, during and after the creation or takeover of the company.

Financial help

Assistance in business creation relates to the investments necessary to start up the activity. Other aids can also be used to compensate for your handicap: accommodation, human aid, equipment purchases, travelling, etc.

Some aids require an analysis of your situation with your supporting counselor who follows you, while others can be requested directly by you from Agefiph.

How to benefit from the support of financial aid from Agefiph

Recognition of disability

To benefit from aid and services from Agefiph, you must have the status of a "disabled person" or have taken steps to do so. Recognition of the status of a disabled worker (RQTH) and/or Disabled Adult Allowance (AAH), issued by the Departmental House for Disabled People (MDPH), gives you access to this status. This is also the case for the disability pension and other titles.
